During the risk assessment process, it is essential to take into consideration the ACGIH occupational exposure levels for inert particulate not otherwise classified (PNOC respirable fraction: 3 mg/m^3 ; PNOC inhalable fraction: 10 mg/m^3). For values above these limits, use a P type filter, with a class (1, 2 or 3) chosen according to the outcome of the risk assessment.

Gypsum is composed of calcium sulphate (CaSO4). Impurities in gypsum-based products usually involve clays, carbonates or marls, depending on where the mineral is quarried, and these may contain small concentrations of silica (amorphous or crystalline).

Gypsum-based products have a zero or very low silica content and, even if present, the quantities are so low as to not pose a significant health risk.

If dusty or powdery material may be generated when handling gypsum-based products, it is recommended to wear a mask, ensure that the workplace is well ventilated, and use protective gloves and goggles.
